Consignor Agrees to the Following:

1. You commit to consigning at least 25 tagged items. We will not accept more than **150 total tagged items**. All limits and restrictions held by L'il Angels Inspection Guidelines and Seller Agreement apply.
2. A flat participation **fee of \$65.00 is required prior to or at the time of item drop-off** and the preparation of the items. This does not include the Consignor Registration Fee paid to L'il Angels Consignment Sale. This fee covers the cost of hangers, cardstock, safety pins, packing tape and any other necessary supplies as well as the Guardian's time and item entry. This also includes transportation of your items to the sale and item disbursement on the sales floor.
3. Consignor understands that you will only receive **60% of the selling price** in your check from L'il Angels Consignment Sale. Please see the "Guardian Angel Tagging Service Guidelines" for volunteer percentages.
4. All items must be freshly laundered (no stains, holes, etc.) and/or wiped down, presentable and functioning, have no missing pieces and working batteries included if applicable.
5. L'il Angels reserves the right to reject any item and may also remove an item from the sale floor at any time. Items that do not meet the L'il Angels quality standards will not be placed on the floor and will be kept until after the sale for pick up unless the request is made for them to be donated.
6. You are placing L'il Angels in charge of preparing your clothes and items for the L'il Angels Consignment Sale. You give us liberty to prepare your clothing by hanging, tagging, and/or whatever else is needed. You understand that we will prepare and price the items with your best interests in mind; however, L'il Angels will not be held responsible for pricing differently than what you would have chosen. Please see the attached "Guardian Angel Tagging Service Guidelines" for more details regarding pricing, preparing for the service, and tips to help you send your best items for sale.
7. Consignor accepts responsibility to schedule an appointment with the tagging service member to drop-off items to be prepared and tagged prior to **Sunday, August 4, 2019**. Email us at tagging@lilangelsconsignment.com.

8. Consignor accepts responsibility to pick-up any unsold merchandise from L'il Angels Consignment Sale on **Sunday, August 25, 2019 from 4:30-5:30 PM** (unless choosing to DONATE all items). You understand that any items not picked up by 5:30 PM will become the property of L'il Angels and will be donated to a chosen local charity.
9. If selling any items included under the PA Bedding & Upholstery Law Act No. 249, you agree to the spraying and tagging methods in accordance to the rules and regulations of the PA Dept. of Labor & Industry. This includes, but is not limited to, Nursery and Toddler bedding including sheets, blankets, comforter sets, decor or any item with 2 or more layers of fabric that would come into contact with a child.
10. Car seats must contain all parts and be clean with no stains. Must NOT have been involved in an accident, NOT be any older than 5 years (after 5 years, straps are no longer guaranteed to hold up in the event of an accident) or has been recalled (call Department of Transportation at 800-424-9393 to identify recalls).
11. Consignor confirms and agrees that they will review The Consumer Product Safety Commission's (CPSC) website (<http://www.cpsc.gov>) prior to your drop off appointment, to ensure that the items consigned are NOT recalled or in anyway in violation of current CPSC guidance.
12. Consignor confirms they have reviewed the Consumer Product Safety Improvement Act of 2008 (15 U.S.C. 1278a(a)) regarding children's products and toys containing lead, choking hazards for children, and mislabeled items that should not be sold in the USA. The updated Act from 2011 can be found here: <https://www.govinfo.gov/content/pkg/BILLS-112hr2715enr/pdf/BILLS-112hr2715enr.pdf>. The law indicates the reseller (Consignor) is responsible for this as L'il Angels provides the facility and is not the reseller since we do not own your items.
13. Consignor agrees that their items may be sprayed according to the PA Bedding and Upholstery Law, Act No. 249. Details can be found here: <https://www.dli.pa.gov/Documents/Regulations/bois/act249.pdf>
14. Consignor will sign and abide by the attached "**Product Recalls & Pest Infestation Policy**". The Guardian Angel Tagging Service reserves the right to refuse items found to be recalled and/or infested with any insect, pest or parasite. This may lead to your name being placed on a blackballed list for not only the tagging service, but possibly L'il Angels Consignment Sale (both Bensalem and Feasterville).
15. All sales are final and no returns, refunds, or credits will be given.
16. You are responsible for picking up any unsold items on **SUNDAY, AUGUST 28, 2019 between 4:30PM-5:30PM** even if you choose to participate in the L'il Angels FEASTERVILLE Consignment Sale, as we do not hold inventory between sales. If you choose to utilize the Guardian Angel Tagging Service for FEASTERVILLE also, you will be required to sign a new contract for that sale and pay a new participation fee. These should be considered separate sales with separate services and they are NOT transferable.
17. Consignor agrees to hold harmless and make no claim against L'il Angels, St. Ephrem Catholic Church, or any volunteer or paid participants in the sale. L'il Angels will do everything possible to protect your interests; however, we are not responsible for fire, theft, damaged, or lost items. Consignor assumes the risks of these events occurring by participating in the sale.
