## PRODUCT RECALLS & PEST INFESTATION POLICY

L'il Angels Consignment Sale follows all guidelines set in place by the Consumer Product Safety Commission (CPSC) regarding the safety and containment of any and all Product Recalls and "infestation threats" to children and families.

We exist to provide a safe, healthy, and community friendly sales environment for our shoppers. L'il Angels Consignment Sale and the Guardian Angel Tagging Service work hard to ensure all items for sale are free from Recalls, as well as insect or pest infestations.

We also follow all Safety Standards defined in the Consumer Product Safety Improvement Act of 2008 (15 U.S.C. 1278a(a)), Section 9. Taken from the statement in the Consumer Product Safety Improvement Act: "Children's products that will contain lead such as children's jewelry, painted wooden or metal toys, flimsy made toys that are easily breakable into small parts and dolls and stuffed toys that have buttons, eyes, noses or other small parts that are not securely fastened and could present a choking hazard for young children." Due to these safety standards and restrictions, the Guardian Angel Tagging Service will take extra precautions to ensure the L'il Angels Consignment Sale standards are upheld to the highest extent. We do not expect perfect items, but we do expect items that are free from recalls, breakage, or issues that could otherwise be prevented by withholding these items to the sale.

We will also withhold ANY items that are found to be infested with pests or insects. For our purposes, pests are defined as "any organism that spreads disease, causes destruction, or is otherwise a nuisance". Examples of the major pests that may be found in a household are cockroaches, bed bugs, fleas or lice. Although the list may extend past this, please ensure you are honest for the sake of our Guardian Taggers and the L'il Angels Consignment Sale by NOT sending items that may be infested with these pests.

Our Guardians work out of their homes or other designated space that these pests could easily spread to and we would like to keep our homes and our sale protected from possible infestations.

For any and all of the reasons above, the Guardian Angel Tagging Service retains the right to REJECT any recalled items found by the tagger. If any pest is found on an item from the consignor, we retain the right to REJECT ALL of the consignor's items, and they will be contacted as soon as possible to pick up their items from the tagger immediately within 24 hours. This may lead to your name being placed on a banned list for not only the tagging service, but possibly L'il Angels Consignment Sale including any and all future sales.
