

# Guardian Angel Service Guidelines

Our tagging service holds a limited number of spots, each spot allows for 150 consigned items with a flat fee of \$70.00 due on/or before your scheduled time slot for drop off. The GA tagging service is a separate service provided for L'il Angels Consignors; however, the fees for this exclusive service are separate from the standard consignor registration fees and paid directly to your Guardian Angel Tagger.

Here's how it works:

Step 1:	Register for our upcoming consignment sale at <a href="http://www.lilangelsconsignment.com">www.lilangelsconsignment.com</a> to secure your spot to sell during open registration.
Step 2:	Review our Guardian Angel Tagging Guidelines below to ensure that this service is right for you. If you are ready to sign-up for our GA Tagging Services, contact us via email at <a href="mailto:tagging@lilangelsconsignment.com">tagging@lilangelsconsignment.com</a> to receive and sign our GA Tagging Services Agreement and schedule a drop off appointment with one of our expert taggers.
Step 3:	<ul style="list-style-type: none"><li>● Gather and pack up to 150 items for tagging and ensure that each item meets our GA Tagging Guidelines below. Note: ONE TAG or ONE ITEM is defined as a single item with one price (one tag) or an outfit/set with one price (one tag) or could also be a toy with several pieces that has one price (one tag). One "tag" or one "item" as referred to in any correspondence relates to the ONE printed cardstock tag for your item(s).</li><li>● Place all items into boxes or bins w/ lids, each labeled with your consignor number. This will ensure your box(es)/bin(s) and lid(s) are returned to you at the close of the sale during the pick-up times: <b>SUNDAY, SEPTEMBER 7, 2025 from 5:00pm-6:00pm.</b></li></ul>
Step 4:	Pay the non-refundable \$70.00 fee directly to your assigned tagger's Venmo or PayPal prior to dropping off your items or bring cash on delivery. Please let us know the form of payment to expect in advance.
Step 5:	<p>Drop off your items at your scheduled time/place with your tagger. We have drop off locations in Northeast Philadelphia and Hatboro.</p> <ul style="list-style-type: none"><li>● We take care of preparation, item entry, pricing, tagging, etc. of your items. We will price your items the same way we would price our own by assessing condition, brand, and fair market value for the best sale possibility. If you have a specific price in mind for a large or high-ticket item, please be sure you communicate this with your tagger.</li><li>● You will be contacted once your items have been placed into inventory for your review. You will have 48 hours to review pricing and make edits to pricing. After this time, the system cannot be changed. Your tagger will be printing and tagging your items for the sale.</li></ul>
Step 6:	<b>Pick up any unsold items at the end of the sale on SUNDAY, SEPTEMBER 7, 2025 5:00pm - 6:00pm unless you choose to "Donate All". We do not store items after the sale closes.</b>
Step 7:	<p>You will receive your sales check via mail within 10 business days after the close of the sale.</p> <ul style="list-style-type: none"><li>● All consignors receive 65% of their total sales.</li><li>● Additional percentage can be earned by completing Volunteer Shifts as follows:<ul style="list-style-type: none"><li>○ One 4-hour shift at any time from Thursday through Sunday of the sale weekend = 70% of total sales</li><li>○ Two 4-hour shifts: One 4-hour shift from Thursday-Saturday + One 4-hour shift on Sunday = 75% of total sales</li></ul></li></ul>

## What is included in the 150 tags vs L'il Angels Consignment's Limits?

### When you register at L'il Angels Consignment Sale, One Consignor Registration includes the following:

- 100 hanger items of which 40 can be NB-18 months, 15 can be maternity and 15 can be Juniors/Young Men's - See JUNIORS LIST
- Onesies are not part of the hanger limit but must be in a Ziploc type bag
- Sleepers NB-18 Months do not count toward the hanger limit, but must be in a Ziplock type bag
- Coats, Costumes, and Dress up do not count toward the hanger limit
- 10 pair of season appropriate shoes that must be in a Ziploc type bag
- Everything else is unlimited however please make sure everything is in good quality, gently used, and working order.

\*\*\*\*\*

If you sign-up for our GA Tagging Services, the \$70.00 non-refundable fee includes a total of 150 tagged items. If you have more than 150 tagged items, you can either tag those additional items yourself by keeping with the above limits OR you can pay an additional \$70.00 non-refundable fee for GA Tagging Services to tag up to 300 tagged items. The Tagging Service provides bags, hangers and additional supplies for preparation.

Note: Two Consignor Registrations with L'il Angels Consignment will double the limits above. However, if you have more than 150 tagged items for the tagging service we will require a second \$70.00 non-refundable fee for a total of 300 possible items.

## What items should I sell?

- We will accept quality children's clothing size Newborn to 16 Youth (child) that are season appropriate. **We only accept select Juniors/Young Men's sizes/brands according to our Inspection Guidelines.**
- Baby/Children/Nursery Furniture including cribs, beds, gliders, dressers, etc. in good functioning condition.
  - NO drop side cribs or cribs that are manufactured prior to SEPTEMBER 2020 (older than 5 years before the sale dates), or recalled items.
  - All parts must be included: screws, bolts, latches, padding, etc.
- **Car seats** that are 5 years old or less. Booster seats that are 10 years old or less. Please follow manufacturer guidelines and check the expiration dates on the back or base of the seat. These cannot expire prior to SEPTEMBER 2026.
- All items must be freshly laundered and wiped down. Items that have an odd smell, covered in an abundance of fur, or defective in any way will be rejected. Please ensure all pieces are included and battery-operated items have fresh batteries. Taggers will test these in advance as they inventory your items. If they do not work, these will be rejected.
- Higher quality name brand items, new with tags, or minimal to no wear/use will sell for a higher dollar amount. Please keep this in mind when selecting your items.
- Clothing with light pilling due to wash and wear may still pass inspection, but please keep in mind that brand, condition and size will have an effect on pricing. All items with stains, imperfections, pulls, holes or other issues will be rejected. Our stain/defect policy is strict. Although we do not expect brand new or like new condition for all items, we do our best to ensure all items on our sales floor are in good pre-owned condition or better.
- Anything infant, child or maternity related can likely be sold at this sale, but feel free to email us with any questions if you are unsure about an item! We do have a quick list of Unacceptable Items on our website for your viewing pleasure.

## What is the best way to group clothing items to create an item or tag?

**Any clothing that you would like to sell as an outfit should be folded or pinned together in a way that makes it an obvious set folded together.**

The sizes should be the same size stated on the manufacturer tag - as an example: A 4T outfit should be a 4T top + 4T pants; a size 5/6 outfit should be a 5/6 top & 5/6 pants.

If your single clothing items may sell better as an outfit due to brand/style/condition/etc, our taggers may create an outfit set for the benefit of the consignor.

### ONE Tag can include two pieces as follows:

- 2-piece outfit with 1 top & 1 bottom
- 2 pairs of bottoms
- 2 tops

### Bagged Clothing - ONE Tag can include:

- Up to 5 Onesies (same size)
- Up to 5 Sleepers (same size)
- Multiple socks
- Hat/Glove/Scarf Set

### ONE Tag can also apply for some 3-piece set exceptions similar to these examples:

- 1 vest + 1 top + 1 bottom
- 1 top + 1 bottom + 1 cardigan
- 1 dress + 1 pair bloomers + 1 cardigan
- 3pc pajamas

## GA's Quick Notes:

- ❖ Communication is key. Please be sure to send an email to "[tagging@lilangelsconsignment.com](mailto:tagging@lilangelsconsignment.com)", even if you have direct contact with your Tagger outside of this email contact. Your tagger will work with you personally throughout the tagging process.
- ❖ All payments for the tagging service, communication after the first email, coordination for drop off, etc should be between you and your Guardian Angel. - ❖ All Recalled or out of date items will be rejected and a warning will be issued to the consignor. We specify that both Car Seats and Cribs/Bassinets cannot be older than 5 years from the sale dates. We do not under any circumstances accept RECALLED ITEMS. All consignors using the GA Tagging Service must read and sign the Contract Addendum.
- ❖ After scheduling a meet with your Tagger to exchange your items, it is important to lightly prepare your items for your tagger.
  - All clothing items should be freshly washed and dry before you meet.
  - You must bring your items in medium-large boxes with 4 walls and closing flaps OR storage bins with lids. This is for the purposes of storage and transport - we want to keep your items clean, safe and together.
  - Clothing should be presentable to ensure your Tagger can easily identify if the item is a single piece or should be an outfit/set/bagged item.
  - Shoes should be in good condition, clean and ensure the rubber sole is not worn down. If they have laces, the laces should also be intact and clean.
  - Toys, large items, infant gear, etc should be wiped down and stain free- we will prepare the items for sale, we will not scrub your items clean.
  - All toys or misc items requiring batteries will need to work before sending them to your tagger and cannot contain battery acid in the battery pack - lack of batteries or finding battery acid will result in rejection. We suggest batteries from Dollar Tree or other inexpensive batteries for this temporary purpose. The goal is to ensure your item works throughout the sale weekend.
- ❖ If your items exceed the 150 item limit, you have the following options:
  - Your tagger will set aside your overage to be returned at the end of the sale with other unsold items. Pick up time is SUNDAY, SEPTEMBER 7, 2025 from 5pm-6pm ONLY.
  - You can pay for an additional Tagging spot for 150 items and your tagger will continue to tag the excess. This is an additional \$70.00 fee to your Guardian Angel and does not override the L'il Angels Consignment Sale overall guidelines.
  - You can tag your additional items yourself under the following terms:
    - You cannot add more items until after your Tagger has printed the inventory they have completed for you.
    - To ensure you comply with the L'il Angels Consignment Sale Guidelines and limitations, you will be required to attend the "Tagging Service Drop Off Time Slot" - THURSDAY, SEPTEMBER 4, 2025 at 7pm. This is the only time slot you would be eligible for.
- ❖ Guardian Angel Tagging Service follows L'il Angels Consignment Sale Limitations and Guidelines. If you only have one registered consignor spot, you will only be able to send 100 hanger items (with additional limits for infant and maternity) and 10 pairs of shoes. Your Tagger will fulfill these limits to max, overages will be rejected and returned at Consignor Pick Up on Sunday after the close of sale.
