~Crib & Sleep Safety Checklist~

Follow these steps to ensure your Crib and "Sleep Stations" meet L'il Angels Consignment Sale's Safety Standards:

Inspect for Damage:

- ☐ Check for any visible damage, such as cracks, bends, or sharp edges on the frame. We will not accept any item with signs of rust or possible impending issues.
- ☐ Look for loose or missing screws, bolts, or other fasteners.
- ☐ We will accept crib mattresses accompanied by a crib, toddler bed, bassinet or other "sleep station" large gear. We will not accept single mattresses to be sold separately.
- ☐ These items **MUST** be built and put together when you drop off to our sale event. This ensures all necessary parts are included and the sleep station is secure. If your item is brand new in a box and never used, the item can be left in its original box for the sale.
- ☐ We will not accept handpainted or modified furniture.

Verify Recall Status:

- ☐ Check to see if your model has been recalled. You can do this by entering the model and serial number on the manufacturer's website or checking the Consumer Product Safety Commission Site - www.cpsc.gov.
- ☐ If there is a Recall on the item that provides a repair to make the item safe, this repair needs to be in place **BEFORE** the item can be sold at our Sale Event.
- ☐ We do not accept Cribs or Sleep Stations manufactured more than 10 years prior to the sale event.

Cleanliness:

- ☐ Thoroughly clean and wipe down your item, including any attached fabrics, and all nooks and crannies.
- ☐ Ensure there are no stains, odors, crumbs or pet hair on the fabric.
- ☐ Use gentle, non-toxic cleaning products to avoid any harmful residues that could be transferred to the next child that uses it.

Verify Compliance with Safety Standards:

- ☐ Ensure all required labels for the product are still visible on the item. This includes the manufacturer's name, model number and manufacturer date.
- ☐ Include the manufacturer's instruction manual. If you do not have the original, one can be printed from the manufacturer's website. Your item cannot be sold without the manual.

Used Crib Safety Checklist Form:

- ☐ This checklist is only necessary to accompany traditional cribs or conversion cribs to the sale event.
- ☐ The L'il Angels Consignment Sale - Used Crib Safety Checklist must be completed and accompany your crib to the sale event. This form can be found on our website: www.lilangelsconsignment.com/preparing-for-the-event, in Consignor Emails, on our Consignor Only Group, at the sale when you drop off or click [HERE](#). This form MUST be completed and placed with your item at the sale or your item will be **REJECTED** due to Safety Standards (this form requires YOUR signature).

Sterilization: Any Sleep Station item with fabric attached must be disinfected at our sale event. Mattresses that accompany a traditional crib or toddler bed must also be sprayed. We are required by law in compliance with the **Bedding and Upholstery Regulation §47.27(b) Secondhand Articles**, to ensure all items of this nature are sterilized prior to placement on our sales floor. This step must be completed at your drop off appointment to our sale. The spray used to sterilize the item is an alcohol based spray. This spray is clear and dries quickly with no lasting odor. Please bring your item to be sanitized to our SPRAY STATION at drop off prior to placing it onto the sales floor.

Please note: Due to the inherent nature of ethyl alcohol (the main ingredient), deep set stains will often resurface when sprayed. This spray does not stain your items, however, it will bring any lingering stain particles to the surface as a natural cleaning reaction. If you do not have your item sterilized at the sale, we will **REJECT** the item from our sales floor as it will be out of **State Licensed Compliance** with our sale event.

This checklist is for the consignor's tagging and inspection information only and is not necessary to accompany the item(s) to the sale event.
